Member Brings Life Long Experience With Homelessness to the Coalition

A valuable member of the New Mexico Coalition to End Homelessness, Paul Lanier knows a lot about homelessness. Born in Oklahoma 61 years ago, Paul experienced severe child abuse at a young age. The resulting trauma that followed him into his early adulthood made him become homeless for the first time in the 80s. Later, Paul relocated to Albuquerque and struggled to find work while living in the streets. He had no address and no phone number he could give to a potential employer and the clothes he wore were a turn-off to business owners. Eventually, however, Paul managed to find a part time job as a cook in downtown Albuquerque. As a result, he was able to move out of the streets into an apartment and for the next seven years he lived a sheltered life. Then, for the next decade, Paul's mental health relapsed. He lost his job and went back to living in the streets on and off, coping by using alcohol and drugs. Eventually, Paul was able to enter a residential treatment program, Albuquerque Rescue Mission. There, for the next 14 months he worked at overcoming his addictions and improving his health. He then entered a dual-diagnosis program at St. Martin's, and was officially diagnosed with post traumatic syndrome and bipolar disorder II. His dual diagnosis enabled him to access resources such as health care, SSDI, Section 8 and Shelter Plus Care. Paul has been using these combined resources for the past four years and has rebuilt and stabilized his life.

Being safe and housed did not make Paul forget the 17,000 individuals struggling with homelessness in New Mexico. He is greatly concerned about "the public stigma related to homelessness and about the 50% undiagnosed individuals living in the street for whom accessing services is the most challenging". To give a voice to those experiencing homelessness, Paul became a member of the New Mexico Coalition to End Homelessness two year ago. He currently serves on three Committees (Continuum of Care, Policy & Advocacy and New Mexico Plan to End Homelessness). Paul is a powerful and respected voice giving a perspective on what homeless life is like, explaining the needs of people living in the street and working at creating solutions to end homelessness!

New Facilities for People Experiencing Homelessness in Farmington

The Four Corners Foundation broke ground in Farmington on November 15 for a new shelter and new transitional housing for people experiencing homelessness. Several of us from NMCEH were fortunate enough to be able to attend. The Four Corners Foundation has been raising money for the new project, which will be operated by another nonprofit, People Assisting the Homeless (PATH). PATH has operated an emergency shelter in Farmington for many years but their current facility is too small and is also wearing out. The new site is in a beautiful a 5.27 acre site spot next to the Animas River. In addition to the new emergency shelter there will be twelve transitional housing apartments, where families or individuals can live while putting their lives back together.

Dr. Matt deKay, the president of the Four Corners Foundation, led a group of supporters in a procession that began in a park, continued over a bridge over the Animas River, and ended at the site of the new project. A group of children then donned yellow hard hats and began digging a hole on the site of the shelter. The new shelter will house up to 60 people and the transitional housing will house 12 households with a total of 12,500 square feet. The emergency shelter part of the project is expected to be completed by summer 2013.

Getting Ready for the 2013 Legislative Session

In January, the New Mexico Legislature will convene for a 60 day legislative session. The NMCEH will be at the Roundhouse lobbying for additional state funding for services that help people who are homeless become stably housed. More specifically, we will be advocating for a \$500,000 increase for the Rapid Re-Housing Program and a \$500,000 increase for the Housing Stability Performance Awards Program. Both these programs are administered by the Mortgage Finance Authority, which then allocates the funds to agencies across the state that serve people experiencing homelessness. Both programs are based on best practices and proven models for ending homelessness The Rapid Re-Housing Program serves individuals and families that need rental assistance and supportive services for a shorter period of time (3-24 months) in order to get back into housing and stabilize their lives. The idea behind Rapid Re-Housing is to help homeless individuals and families quickly obtain permanent housing where they can continue to live even after assistance ends. Housing Stability Awards are allocated to programs that have a strong, proven track record of helping homeless individuals and families achieve housing stability. One specific type of program is permanent supportive housing programs, which serve people with disabilities who need long term housing assistance and supportive services in order to stay housed.

Please plan to join us for our 7th Annual Lobby Day, Wednesday January 23, 2013 from 8:00 am to 12:00 pm! This is our opportunity to tell legislators directly that New Mexico must invest in solutions to homelessness. Staff members, people who have experienced homelessness, board members, volunteers and community members are all welcome. More details coming soon !
