Good news in the Mesilla Valley

Mesilla Valley Community of Hope (MVCH) serves clients that are currently homeless or on the brink of homelessness. We provide support through a myriad of services to help people get back on their feet and off the streets. Southern New Mexico is facing a time where housing units are scarce and rent prices are soaring far above Fair Market Rent. This puts our communities at higher risk for homelessness and housing insecurity.

We are excited to announce our recent success in garnering a grant from the City of Las Cruces to use ARPA funds to implement a Landlord/Housing Risk Mitigation program. With these funds, MVCH seeks to attract landlords to partner with our rental assistance programs as well as to maintain and nurture our current landlord partnerships.

Here are some of the ways MVCH plans to utilize the funding:

- Extraordinary damages in excess of the security deposit
- Extraordinary cleaning and pest infestation
- Delinguent rent up to two months
- Rent over Fair Market Rent
- Bringing units up to Habitability standards
- Other costs required to recruit and/or retain landlords

We hope that this will help bring in new units and help our clients transition more quickly from the streets to their own home, while also providing a more sustainable way to keep currently housed clients in their units.

I have decided to retire from my position as Executive Director and the Board is actively searching for the next Executive Director. I will stay on until the new person is comfortable in the position. Running NMCEH was always my dream job, and I have enjoyed working with all the members and supporters of the New Mexico Coalition to End Homelessness over the last 21 years. When I started as Executive Director, I was the only employee. Now there are 32 staff members working on supporting member agencies in the work to house everyone in New Mexico. Retiring from NMCEH will allow me to devote my full attention to my new position as a Santa Fe County Commissioner, and it will allow someone with fresh energy to take over at NMCEH.

While the problem of homelessness still exists, it is also true that many thousands of people have been helped out of homelessness over the years due to our combined efforts. There are hundreds more housing units for people experiencing homelessness than when we started NMCEH, and our system of coordinated entry is helping connect people to housing more quickly. The Homeless Management Information System at NMCEH gives accurate up to date data on homelessness, which is very useful for advocacy. Moving forward, we now have more tools to help toward the goal of housing everyone. I will be looking for the best ways to stay involved as I take a step back.
